## Resolution No. 12-001 March 26, 2012 Village of Chatham Planning Board

**WHEREAS**, Hampshire Companies has submitted an application for site plan approval to expand the grocery store component of its existing Chatham Retail Plaza from 43,830 square feet to 60,116 sq. feet (hereinafter "the Project"); and

**WHEREAS**, the Project is situated across the street from the Blinn-Pulver Farmhouse, a historic site listed on the National Register of Historic Places; and

**WHEREAS**, regulations promulgated pursuant to the State Environmental Quality Review Act (SEQRA), at 6 NYCRR 617.4(b)(9), an "Unlisted action" occurring "substantially contiguous" to any historic building listed on the National Register of Historic Places is a Type I action; and

**WHEREAS**, as proposed, the Project will require approvals from the following involved agencies: Village of Chatham Planning Board, the NYS Department of Environmental Conservation, and the Village of Chatham Trustees; and

**WHEREAS**, pursuant to 6 NYCRR 617.6, the environmental review of a Type I action must be coordinated; and

**WHEREAS**, the Village Planning Board has now deemed the Project application complete for purposes of environmental review pursuant to SEQRA; and

**WHEREAS**, the Village Planning Board desires Lead Agency Status to conduct such environmental review.

NOW THEREFORE, the Village of Chatham Planning Board hereby:

- 1. Determines that the Project is a "Type I" action pursuant to SEQRA; and
- 2. Directs counsel to issue coordination letters seeking Lead Agency status for and on behalf of the Village of Chatham Planning Board.
