Asked if there is an outside contractor that village can request to clear sidewalks of snow if DPW is not available to do so. Repeated request for striping in municipal parking lot. Requested more info on parking committee. Asked if costs were included in John G Waite contract. Suggested that Birch should pay immediately without penalties while village determines if penalties are due. Requested that actual date of meter read be added to water/sewer bills. Suggested that the village take into account its costs when discussing fees and fines at upcoming meeting.
