## Items for Discussion:

2014-2015 AUD - The VOC has a General Fund balance of over \$500,000. Some of these funds are for the Tracy Memorial and remaining funds from Ellsworth Kelly for the parking lot. The Water Fund has a positive balance but the Sewer Funds are in the negative. This could be due to the fact that monies are deposited just into the Water Fund. It is not split between the two Funds at this time. If there are any questions related to the AUD, please feel free to sit down with C/T Henry to discuss your questions. The Supervisor for the Town of Chatham would like to have a workshop in April to talk about the Town of Chatham and the Village of Chatham being combined (at the Tracy).
