A scheduled Public Hearing on Local Law No. 4 of 2015, to extend and clarify the moratorium on development of certain types in the Village of Chatham preceded the start of the Board Meeting. Resolution: To approve use of the Tracy Memorial Hall for music and crafts vendors during WinterFest. So moved by Trustee Packet seconded by Trustee Wollowitz approved by all Trustees present.

Resolution: To approve Local Law, No 4 of 2015, to extend and clarify a moratorium on certain described types of development in the Village of Chatham. So moved by Trustee Packet seconded by Trustee Rippel approved by all Trustees present.

Resolution: To approve authorizing water facilities improvement projects for the water tower for the Village of Chatham, authorizing the issuance of serial bonds of the Village of Chatham in an aggregate principal amount not to exceed \$295,100.00. Resolution: To forgive the current sewer bill for all Harmon Heights residents. So moved by Trustee Packet seconded by Trustee Rippel approved by all Trustees present.

Resolution: To change the method for billing Harmon Heights residents for sewer services from \$96.00 per quarter to \$21.00 for the first bathroom; \$17.00 for the second bathroom; \$13.00 for the third bathroom and \$12.00 for each bathroom beyond three bathrooms. So moved by Trustee Packet seconded by Trustee Wollowitz approved by all Trustees present.

Resolution: To approve the use of the Village Green at Park Row and Main Street for the annual Veterans' Day program on Saturday, November 7, 2015 starting at 11:00 AM. So moved by Trustee Packet seconded by Trustee Rippel approved by all Trustees present.

Resolution: To change the current billing status with NYSEG to account for change to LED light bulbs as they need replacement. So moved by Trustee Packet seconded by Trustee Wollowitz approved by all Trustees present.
