Sealed bids for Woodbridge Ave Paving will be received at the Village hall 77 Main Street, Chatham NY, 12037, on or before 1:00 on July 6, 2017. At that time the bids will be publicly opened and recorded to be approved by the board at the next available meeting.

Bidders are responsible for submitting their bids to the appropriate location prior to the time and date as stated. **NO BIDS WILL BE ACCEPTED AFTER THE DESIGNATED TIME AND DATE INDICATED.** It is recommended that Proposals be submitted in advance at least one day prior to bid opening. Delay in mail is NOT an exception to the receipt bid.

Bidders shall indicate, on the **outside of their sealed bid and mailing envelope** the following information:

Failure to do so may result in rejection of bid as being unresponsive.

The following forms are necessary to be submitted as well as any additional forms requested in the specifications:

2. **Non Collusion affidavit,** completed signed and dated

- Bidder may not withdraw a bid within forty five (45) days after actual date of bid opening

Expect 15 (+/-) 2 Driveway aprons will need handwork (Approx. 12' X 4') include with price per ton bid

The price is to be quoted as "in Place" which includes the following. Trucking, material, Placement and rolling. Please also include an estimate of how much material is needed.

Include T&L.

Item 1: Price quoted as in place, of type 3 binder (600' X 40' X 3")

Item 2: Price quoted as in place, of type 6 top (600' X 40' X 1.5")

Item 3: Price for Mobilization of all equipment

NON-COLLUSION BIDDING CERTIFICATE

Section 103-d of the General Municipal Law requires every bid or proposal made to a political subdivision, or any public department, agency or official, where competitive bidding is required by statute, rule, regulation or local law, to contain a Non-Collusion Bidding Certificate in the following form:

 3. No attempt has been made or will be made by the bidder to induce any other person, partnership or corporation to submit or not to submit a bid for the purpose of restricting competition.
