## **New Business:**

- 1. **Resolution:** To approve the Commercial Insurance Bid from Trident Public Risk at a cost of \$48,264.55 as presented by Metzwood Insurance Agency. So moved by Trustee Packet; seconded by Trustee Rippel. Approved by all.

  - a) Late Notice will be mailed two (2) weeks after due date if payment has not been received.
  - **b)** Additional five percent (5%) penalty fee will be applied three (3) weeks after due date if payment has not been received.
  - c) Shut off Letter will be mailed four (4) weeks after due date if payment has not been received.
  - d) Shut off Notice will be posted six (6) weeks after due date if payment has not been received and as allowed by law. Service will be shut off 24-48 hours after this posting.
