Special Meeting MINUTES

Call to Order (Regular Meeting): 6:00pm by Mayor Howe, with Pledge of Allegiance. **Present:** Mayor Howe; Trustees K. Schassler, P. Minahan; Clerk D. Kelleher; D. Clerk S. Davis, Jr.; CPD A. Chief J. Alessi; Resident Jim Simmons.

First Public Comment (limited to 15 minutes): Resident Jim Simmons expressed his appreciation to the Village for assisting the residents by authorizing the DPW to clear the sidewalks after the recent overwhelming storm.

NEW BUSINESS:

Resolution 25 of 2023 — To approve, and authorize the Mayor to sign a Shared Services Agreement dated 3/23/2023 between NYSDOT and the Village of Chatham, for a 4-year period from 3/23/2023 to 03/23/2027.

So moved by K. Schassler, seconded by P. Minahan. Approved by all.

<u>Resolution 26 of 2023</u> – To authorize the DPW to purchase **GPS hardware** in the amount of \$2775, per the Quote #1236 dated 02/22/2023, from Land Logics Group. So moved by P. Minahan, seconded by K. Schassler. Approved by all.

Resolution 27 of 2023 – To authorize the DPW to purchase an Apple iPad Pro 12.9 inch 6th Gen – 256GB w/free case and screen protector, not to exceed \$1199.99, from T-Mobile Government Services Unlimited Plan under NYS contract #PS68707. So moved by K. Schassler, seconded by P. Minahan. Discussion: A. Chief J. Alessi advised the Board that he verified the contract price to now be \$1199.99, which is \$200 less than originally thought. Approved by all.

<u>Resolution 28 of 2023</u> — To authorize the DPW to purchase <u>iPad Data Services</u> through the <u>T-Mobile Government Unlimited Plan</u> under NYS contract <u>#PS68707</u>, in the amount of \$35 per month. So moved by P. Minahan, seconded by K. Schassler. Discussion: A. Chief J. Alessi remarked that "iPad Data Services" is cell phone service for the iPad. Approved by all.

Resolution 29 of 2023 - To authorize the DPW to purchase AppleCare+, within 60-days of purchase of the Apple iPad Pro, in the amount of \$7.99 per month. So moved by K. Schassler, seconded by P. Minahan. Discussion: A. Chief J. Alessi stated that AppleCare+ is an insurance plan for the iPad. Apple may need to be paid/bill through the Village credit card. Approved by all.

<u>Resolution 30 of 2023</u> – To accept, and authorize the Mayor to sign the <u>Light</u> Emitting Diode (LED) Street Light Conversion Letter Agreement dated March 6, 2023, between New York State Electric and Gas (NYSEG) and the Village of Chatham. So moved by P. Minahan, seconded by K. Schassler. Approved by all.
